RECOMMENDATIONS FOR USE

SYNOCURE® 9299 BA 70 MY should be mixed with the selected polyisocyanate just prior to application. It is preferable to use stoichiometric ratios to obtain optimum performance.

The reaction ratio is calculated from the respective equivalent weight or hydroxyl and isocyanate content of the reactants. The relationship is:

Hydroxyl equivalent weight = $\frac{17 \times 100}{\% \text{ OH}}$

Isocyanate equivalent weight = $\frac{42 \times 100}{\% \text{ NCO}}$

Using Tolonate[™] HDT-LV2 (1), the recommended ratios would be:
